19	the access to the two access points shown on the site
20	plan, 2) return right-of-way area along West Seventh
21	Street to grass and remove pavement forward of the
22	proposed parking area along Frayser Avenue and return
23	to grass as shown on the site plan, 3) install the
24	required landscaping as shown on the site plan, and 4)
25	pave the parking area to the rear of the building as

- 1 shown on the site plan.
- 2 MR. SILVERT: Mr. Chairman, before you proceed

- I think you might want to ask if there's anyone here
- 4 who would like to speak against this item.
- 5 CHAIRMAN: Does anyone have any opposition on
- 6 this item who wants to speak against it or anything?
